1. ON SEPTEMBER 24, 1991 (E-MAIL #1267113), LIQUIDATION INSTRUCTIONS WERE ISSUED FOR SUBJECT MERCHANDISE COVERED BY THE COUNTERVAILING DUTY ORDER ON FRESH CUT FLOWERS FROM ECUADOR (C-331-601) AND EXPORTED ON OR AFTER JANUARY 1, 1989 AND ON OR BEFORE DECEMBER 31, 1989.

2. THIS MESSAGE CLARIFIES THAT THE "ALL OTHER FIRM" RATE OF 1.12 PERCENT APPLIES TO ALL FIRMS OTHER THAN THOSE INDIVIDUALLY IDENTIFIED ON THE INSTRUCTIONS. SPECIFICALLY, THE FIRMS OF

FLORES DEL EQUADOR (C-331-601-001), FLORES LA ANTONIA (C-331-601-004), INVERSIONES FLORICOLA (C-331-601-006), QUITO FLORES (C-331-601-009) AND VICTOR GUALA SALAZAR (C-331-601-010) SHOULD BE LIQUIDATED AT ZERO AS INSTRUCTED IN THE REFERENCED E-MAIL. ALL OTHER FIRMS (C-331-601) WITH EXPORTS DURING THE 1989 PERIOD SHOULD BE LIQUIDATED AT 1.12 PERCENT OF THE F.O.B. INVOICE PRICE.
