ON 12/22/1999, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE COUNTERVAILING DUTY ORDER OR FINDING ON STAINLESS STEEL SHEET AND STRIP IN COILS FROM FRANCE (C - 427-815) MANUFACTURED BY USINOR, UGINE S.A., AND UGINOX SALES CORPORATION ON OR AFTER AUGUST 6, 1999.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES

OF SUBJECT MERCHANDISE PRODUCED AND/OR EXPORTED BY USINOR, UGINE,
AND UGINOX SALES CORPORATION C-427-815-001, AND WHICH WERE
ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER

08/06/1999 AND WHICH REMAIN UNLIQUIDATED AFTER JANUARY 20, 2000,
THE DATE ON WHICH THE INJUNCTION WAS SERVED ON CBP AND THE
DEPARTMENT. CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRIES
UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED. ANY
ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET
IMMEDIATELY.
