THE DEPARTMENT OF COMMERCE PUBLISHED IN THE FEDERAL REGISTER OF 12/12/2001 (66 FR 64214), THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF THE COUNTERVAILING DUTY ORDER ON CERTAIN PASTA FROM ITALY FOR THE PERIOD 1/1/1999 THROUGH 12/31/1999. THIS IS A CORRECTION OF MESSAGE 3343213, DATED DECEMBER 9, 2003. SPECIFICALLY, PARAGRAPH 2 OF THAT MESSAGE WAS INCORRECT, AND SHOULD READ AS FOLLOWS:

PURSUANT TO THE SETTLEMENT AGREEMENT, DELVERDE'S NET SUBSIDY RATE

WAS SET AT 2.13 PERCENT AD VALOREM FOR THE PERIOD 1/1/1999 THROUGH 12/31/1999. ACCORDINGLY, YOU ARE NOW INSTRUCTED TO LIQUIDATE ALL SHIPMENTS OF CERTAIN PASTA FROM ITALY BY DELVERDE ENTERED, OR WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION ON OR AFTER

1/1/1999 AND ON OR BEFORE 12/31/1999 AT 2.13 PERCENT OF ENTERED VALUE.
