ON 02/26/2004, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER OR FINDING ON CERTAIN PASTA FROM ITALY (A-475-818), PRODUCED AND OR EXPORTED BY INDUSTRIA ALIMENTARE COLAVITA S.P.A. (ALSO KNOWN AS INDALCO S.P.A.) AND/OR FUSCO S.R.L., AND WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 07/01/2001 AND ON OR BEFORE 06/30/2002.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE PRODUCED AND OR EXPORTED BY INDUSTRIA ALIMENTARE COLAVITA S.P.A. (ALSO KNOWN AS INDALCO S.P.A.) AND/OR FUSCO S.R.L, AND WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 07/01/2001 AND ON OR BEFORE 06/30/2002. ANY ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
