THE DEPARTMENT OF COMMERCE HAS COMPLETED ITS ADMINISTRATIVE REVIEW OF THE ANTIDUMPING FINDING ON LARGE POWER TRANSFORMERS FROM FRANCE FOR THE PERIOD 1991 THROUGH 1992 AND PUBLISHED THE FINAL RESULTS IN THE FEDERAL REGISTER ON AUGUST 23, 1993 (58 FR 44497). THERE WERE NO SHIPMENTS DURING THIS REVIEW PERIOD.

2. ACCORDINGLY, FOR SHIPMENTS OF LARGE POWER TRANSFORMERS EXPORTED BY JEUMONT SCHNEIDER TRANSFORMATEURS (A-427-030-002) ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR

AFTER AUGUST 23, 1993 CUSTOMS OFFICERS SHALL COLLECT A CASH DEPOSIT OF 24 PERCENT. THIS RATE IS ALSO APPLICABLE IF THE EXPORTER HAS NO RATE AND JEUMONT SCHNEIDER TRANSFORMATEURS IS THE MANUFACTURER. (SEE PARAGRAPH 3.)

3. FOR ANY ENTRIES OF THIS MERCHANDISE FROM PREVIOUSLY REVIEWED MANUFACTURERS OR EXPORTERS NOT COVERED BY THIS REVIEW, THE CASH DEPOSIT WILL CONTINUE TO BE AT THE RATE PUBLISHED IN THE FINAL RESULTS OF THE LAST ADMINISTRATIVE REVIEW FOR EACH OF THOSE FIRMS. IF THE EXPORTER IS NOT A FIRM COVERED IN THIS REVIEW, OR A PRIOR REVIEW, BUT THE MANUFACTURER IS, THE CASH DEPOSIT RATE WILL BE THE RATE ESTABLISHED FOR THE MOST RECENT PERIOD FOR THE MANUFACTURER OF THE MERCHANDISE. FOR ANY ENTRIES OF THIS MERCHANDISE FROM A MANUFACTURER AND EXPORTER NOT COVERED IN THIS OR PRIOR ADMINISTRATIVE REVIEWS AND WHO IS UNRELATED TO ANY REVIEWED FIRM OR ANY PREVIOUSLY REVIEWED FIRM, A CASH DEPOSIT OF 24 PERCENT SHALL BE REQUIRED.
4. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS OF THE NEXT ADMINISTRATIVE REVIEW.
5.
