1. THE DEPARTMENT OF COMMERCE DID NOT RECEIVE A REQUEST FOR AN ADMINISTRATIVE REVIEW OF THE COUNTERVAILING DUTY ORDER ON FRESH CUT FLOWERS FROM PERU (C-333-601) FOR THE REVIEW PERIODS COVERING OCTOBER 27, 1986 THROUGH DECEMBER 31, 1990.
2. THE MERCHANDISE COVERED BY THESE INSTRUCTIONS IS POMPON CHRYSANTHEMUMS FROM PERU (C-333-601) CURRENTLY PROVIDED FOR UNDER HARMONIZED TARIFF SCHEDULE ITEM NUMBER 0603.10.70.10. DURING THE REVIEW PERIODS, THE MERCHANDISE WAS CLASSIFIED

REVENUE CODE OF 1954 FOR SUCH PERIOD. THE INTEREST SHALL BE CALCULATED AT THAT RATE FROM THE DATE OF PAYMENT OF ESTIMATED DUTIES THROUGH THE DATE OF LIQUIDATION. HOWEVER, NO INTEREST SHOULD BE COLLECTED OR PAID ON SUBJECT MERCHANDISE EXPORTED ON OR AFTER OCTOBER 27, 1996 WHICH ENTERED BEFORE FEBRUARY 24, 1987.
