1. ON 03/24/2004 THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION IN DONGGUAN FAY CANDLE CO., LTD. ET AL. V. UNITED STATES, COURT NO. 04-00134 ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-504-004), MANUFACTURED OR EXPORTED BY DONGGUAN FAY CANDLE CO., LTD. FOR THE PERIOD 08/01/2001 THROUGH 07/31/2002.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE PRODUCED OR EXPORTED BY DONGGUAN FAY CANDLE CO., LTD. (004) AND WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 08/01/2001 AND ON OR BEFORE 07/31/2002. CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED. ANY ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY. DO NOT LIQUIDATE ENTRIES THAT REMAIN UNLIQUIDATED AS OF 5:00 P.M. ON APRIL 1, 2004.
