RE: Temporary Restraining Order on Diamond Sawblades and Parts Thereof from the People's Republic of China (A-570-900), court number 09-00511

1. On 03/06/2013, the U.S. Court of International Trade issued a Temporary Restraining Order (TRO) temporarily restraining the Department of Commerce and CBP from the following.

a. Excluding or revoking the AT&M entity and/or any its members (as described below) from the antidumping duty order on diamond sawblades and parts thereof from the People's Republic of China (A-570-900). The members of the AT&M entity are:

Advanced Technology & Materials Co., Ltd.;

Beijing Gang Yan Diamond Products Co. (aka Beijing Gang Yan Diamond Products Co., Ltd., Beijing Gang Yan Diamond Products Company);

HXF Saw Co., Ltd. (fka Yichang HXF Circular Saw Industrial Co., Ltd.);

AT&M International Trading Co., Ltd. (aka ATM International Trading Co., Ltd.); and

Cliff International Ltd. (aka Cliff (Tianjin) International Ltd., Cliff (Tianjin) International Ltd., Company).

b. Ordering the lifting of the suspension of liquidation regarding incoming entries of diamond sawblades and parts produced and/or exported by these companies and otherwise subject to the antidumping duty order on diamond sawblades and parts thereof from the People's Republic of China (A-570-900).

c. Making or permitting liquidation of any unliquidated entries of diamond sawblades and parts thereof produced and/or exported by these companies that: are subject to the final results of the less-than-fair-value investigation (71 FR 29303, May 22, 2006), as amended by the amended final determination (71 FR 35864, June 22, 2006); remain unliquidated as of 5:00 p.m. on 03/14/2013.

2. This TRO was issued in connection with court case number 09-00511 and enjoins liquidation of the entries described above. This TRO shall be effective for all entries which remain unliquidated as of 5:00 p.m. on 03/14/2013 and shall remain in effect until such time as the court rules on the plaintiff's motion for preliminary injunction against liquidation.

3. Liquidation instructions for entries affected by the TRO have not yet been issued.

4. Accordingly, effective 03/07/2013, and until such time as the court rules on the Plaintiff's motion for preliminary injunction against liquidation, CBP is instructed not to liquidate entries of merchandise subject to the TRO as described in paragraph 1. Any entries that are set for liquidation must be unset immediately. Continue to suspend liquidation of other entries of diamond sawblades and parts thereof from the People's Republic of China that were produced and/or exported by the AT&M entity and/or any of its members (as described above in paragraph 1) and that were entered, or withdrawn from warehouse, for consumption at any time until liquidation instructions are issued.
