1. THE U.S. COURT OF INTERNATIONAL TRADE HAS ISSUED A
PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF ENTRIES WHICH
ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON TAPERED ROLLER
BEARINGS AND PARTS THEREOF, FINISHED AND UNFINISHED, FROM
JAPAN AND WHICH WERE MANUFACTURED AND EXPORTED BY KOYO SEIKO
CO., LTD., NTN BEARING CO. LTD., NSK LTD., OR NACHI-FUJIKOSHI

CORPORATION FROM AUGUST 1, 1990 THROUGH SEPTEMBER 30, 1992.

2. THEREFORE, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WAS PRODUCED OR EXPORTED BY KOYO SEIKO CO., LTD., NSK LTD., NTN BEARINGS CO., LTD., OR NACHI-FUJIKOSHI CORPORATION AND WHICH WAS ENTERED FOR CONSUMPTION OR WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION FROM

AUGUST 1, 1990 THROUGH SEPTEMBER 30, 1992, AND WHICH REMAIN UNLIQUIDATED AT THE CLOSE OF BUSINESS FEBRUARY 21, 1994.
