ON 09/22/1997, THE INTERNATIONAL TRADE COMMISSION (ITC) NOTIFIED THE DEPARTMENT OF COMMERCE OF ITS NEGATIVE DETERMINATION IN THE ANTIDUMPING DUTY INVESTIGATION OF OPEN-END SPUN RAYON SINGLES YARN FROM AUSTRIA (A-433-807). THE ANTIDUMPING DUTY INVESTIGATION OF OPEN-END SPUN RAYON SINGLES YARN FROM AUSTRIA HAS BEEN TERMINATED. THIS MESSAGE SUPERSEDES MESSAGE NUMBER 8283114, DATED 10/10/1997, BY CHANGING THE EFFECTIVE DATE FOR THE DISCONTINUANCE OF SUSPENSION OF LIQUIDATION FROM

09/22/1997 TO 03/26/1997.

2. FIELD OFFICES SHOULD DISCONTINUE SUSPENSION OF LIQUIDATION OF ALL SHIPMENTS OF THIS MERCHANDISE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 03/26/1997. ALL ESTIMATED ANTIDUMPING DUTIES DEPOSITED ON ENTRIES OF THE SUBJECT MERCHANDISE SHALL BE REFUNDED AND THE BONDS OR OTHER SECURITY RELEASED AT THE TIME OF LIQUIDATION.

3. INTEREST PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930 DO NOT APPLY.
