THE U.S. COURT OF INTERNATIONAL TRADE HAS ISSUED A PRELIMINARY INJUNCTION ENJOINING THE LIQUIDATION OF CERTAIN AFB ENTRIES DURING THE PERIOD MAY 1, 1991 THROUGH APRIL 30, 1992 (THIRD REVIEW), SUBJECT TO THE ANTIDUMPING DUTY ORDERS ON ANTIFRICTION BEARINGS (AFBS) (OTHER THAN TAPERED ROLLER BEARINGS) AND PARTS THEREOF FROM FRANCE, AND EXPORTED OR MANUFACTURED BY THE COMPANIES LISTED BELOW.

2. UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF

ANTIFRICTION BEARINGS (AFBS) (OTHER THAN TAPERED ROLLER BEARINGS) AND PARTS THEREOF FROM FRANCE THAT WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD MAY 1, 1991 THROUGH APRIL 30, 1992 AND THAT WERE PRODUCED OR EXPORTED BY:

SOCIETE NOUVELLE DE ROULEMENTS ("SNR")  
SKF FRANCE (INCLUDING SKF COMPANIE D'APPLICATIONS MECANIKUES,  
S.A., ADR AND SARMA)

3. WITH RESPECT TO ENTRIES OF REVIEWED FIRMS NOT COVERED BY AN INJUNCTION, APPRAISEMENT INSTRUCTIONS HAVE ALREADY BEEN ISSUED OR WILL BE FORTHCOMING. IF YOU HAVE NOT RECEIVED APPRAISEMENT INSTRUCTIONS FOR THESE ENTRIES, CONTINUE TO SUSPEND LIQUIDATION UNTIL SPECIFIC APPRAISEMENT INSTRUCTIONS ARE ISSUED.
