THE U.S. COURT OF INTERNATIONAL TRADE HAS ISSUED A PRELIMINARY INJUNCTION ENJOINING THE LIQUIDATION OF CERTAIN AFB ENTRIES DURING THE PERIOD MAY 1, 1991 THROUGH APRIL 30, 1992 (THIRD REVIEW), SUBJECT TO THE ANTIDUMPING DUTY ORDERS ON ANTIFRICTION BEARINGS (AFBS) (OTHER THAN TAPERED ROLLER BEARINGS) AND PARTS THEREOF FROM GERMANY, AND EXPORTED OR MANUFACTURED BY THE COMPANIES LISTED BELOW.

2. IN CERTAIN CASES, THE INJUNCTION ONLY COVERS BALL BEARINGS.

THIS IS INDICATED IN PARENTHESES NEXT TO THAT PARTICULAR FIRM'S NAME. ANY ENTRIES FROM THESE FIRMS WHICH INCLUDE ANY BALL BEARINGS FROM GERMANY ARE COVERED BY THE COURT INJUNCTION.

3. UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF ANTIFRICTION BEARINGS (AFBS) (OTHER THAN TAPERED ROLLER BEARINGS) AND PARTS THEREOF FROM GERMANY THAT WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD MAY 1, 1991 THROUGH APRIL 30, 1992 AND THAT WERE PRODUCED OR EXPORTED BY:

FICHTEL AND SACHS (BALL BEARINGS ONLY)
INA WALZLAGER SCHAEFFLER KG AND INA BEARING COMPANY
SFK GMBH, SKF SERVICE GMBH, AND STEYR WALZLAGER/FAG
KUGELFISCHER GEORG SCHAEFER KGAA/NTN KUGELLAGERFABRIK
(DEUTSCHLAND) GMBH

4. WITH RESPECT TO ENTRIES OF REVIEWED FIRMS NOT COVERED BY AN INJUNCTION, APPRAISEMENT INSTRUCTIONS HAVE ALREADY BEEN ISSUED OR WILL BE FORTHCOMING. IF YOU HAVE NOT RECEIVED APPRAISEMENT INSTRUCTIONS FOR THESE ENTRIES, CONTINUE TO SUSPEND LIQUIDATION UNTIL SPECIFIC APPRAISEMENT INSTRUCTIONS ARE ISSUED.
