CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED. ANY ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY. DO NOT LIQUIDATE ENTRIES THAT REMAIN UNLIQUIDATED AS OF 5:00 P.M. ON 05/20/2004.
