1. ON 5/21/2004, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON STEEL CONCRETE

REINFORCING BAR (REBAR) FROM THE REPUBLIC OF KOREA (KOREA) (A-580-844), MANUFACTURED OR EXPORTED BY DONGKUK STEEL MILL, CO., LTD. (DSM) OR DONGKUK INDUSTRIES CO., LTD. (DKI) FOR THE PERIOD 01/30/2001 THROUGH 08/31/2002.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WAS PRODUCED OR EXPORTED BY DSM OR

DKI AND WHICH WAS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 01/30/2001 THROUGH 08/31/2002. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED. ANY ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
