NITROMETHANE FROM PRC (A-570-823)

1. THE ANTIDUMPING DUTY INVESTIGATION OF NITROMETHANE FROM THE PEOPLE'S RUPUBLIC OF CHINA HAS BEEN TERMINATED. ON MAY 6, 1994 THE INTERNATIONAL TRADE COMMISSION NOTIFIED THE DEPARTMENT OF COMMERCE OF IT'S FINAL DETERMINATION THAT AN INDUSTRY IN THE UNITED STATES IS NOT MATERIALLY INJURED OR THREATENED WITH MATERIAL INJURY, AND THE ESTABLISHMENT OF AN INDUSTRY IN THE UNITED STATES IS NOT MATERIALLY RETARDED, BY REASON OF IMPORTS OF NITROMETHANE FROM THE PRC.

2. LIQUIDATION INSTRUCTIONS

FIELD OFFICES SHOULD DISCONTINUE SUSPENSION OF LIQUIDATION OF ENTRIES FOR MERCHANDISE ENTERED OR WITHDRAWN FROM THE WAREHOUSE FOR CONSUMPTION ON OR AFTER AUGUST 10, 1993. ALL ESTIMATED ANTIDUMPING DUTIES DEPOSITED ON ENTRIES OF THE SUBJECT MERCHANDISE SHALL BE REFUNDED AND THE BONDS OR OTHER SECURITY RELEASED AT THE TIME OF LIQUIDATION.

3. INTEREST PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930 DO NOT APPLY.
