1. ON 04/14/2004, THE DEPARTMENT OF COMMERCE PUBLISHED IN THE FEDERAL REGISTER ITS INITIATIONS OF ANTIDUMPING AND COUNTERVAILING DUTY INVESTIGATIONS OF LIVE SWINE FROM CANADA (69 FR 19815 AND 69 FR 19818).

2. FOR PURPOSES OF THESE INVESTIGATIONS, THE PRODUCTS COVERED ARE ALL LIVE SWINE FROM CANADA EXCEPT U.S. DEPARTMENT OF AGRICULTURE CERTIFIED PUREBRED BREEDING SWINE. LIVE SWINE ARE DEFINED AS FOUR-LEGGED, MONOGASTRIC (SINGLE-CHAMBERED STOMACH),

LITTER-BEARING (LITTERS TYPICALLY RANGE FROM 8 TO 12 ANIMALS), OF THE SPECIES SUS SCROFA DOMESTICUS. THIS MERCHANDISE IS CURRENTLY CLASSIFIABLE UNDER HARMONIZED TARIFF SCHEDULE OF THE UNITED STATES ("HTSUS") SUBHEADINGS 0103.91.0010, 0103.91.0020, 0103.91.0030, 0103.92.0010, 0103.92.0090.

ALTHOUGH THE HTSUS SUBHEADINGS ARE PROVIDED FOR CONVENIENCE AND CUSTOMS PURPOSES, THE WRITTEN DESCRIPTION OF THE MERCHANDISE UNDER INVESTIGATION IS DISPOSITIVE.

3. FOR FURTHER REPORTING PURPOSES, THESE CASES HAVE BEEN ASSIGNED INVESTIGATION NUMBERS A-122-850 AND C-122-851.
