1. THIS OFFICE HAS SENT AN INFORMATION REQUEST RECEIVED FROM THE DEPARTMENT OF COMMERCE TO THE C.I.E. THE REQUEST SOLICITS CONFIRMATION THAT AN ATTACHED LISTING OF COLOMBIAN COMPANIES DID NOT SELL FLOWERS SUBJECT TO THE ANTIDUMPING ORDER TO THE UNITED STATES DURING THE FIFTH, SIXTH AND SEVENTH ADMINISTRATIVE REVIEWS.

2. A THOROUGH REVIEW SHOULD BE CONDUCTED TO DETERMINE IF THESE

SUPPLIERS/GROWERS APPEAR ON ANY SUSPENDED ENTRY SUMMARIES. IF SO, HQTS NOTIFICATION SHOULD BE MADE IN ACCORDANCE WITH PARAGRAPH 4.

3. BE ON THE LOOKOUT FOR THIS UPCOMING C.I.E. ISSUANCE.

4. ALL POSITIVE RESPONSES SHOULD BE MADE WITHIN THIRTY DAYS OF THE DATE OF THE C.I.E. ISSUANCE VIA E-MAIL TO THE ANTIDUMPING/COUNTERVAILING DUTY BRANCH USING ATTRIBUTE "HQ OAB." NEGATIVE RESPONSES ARE NOT REQUIRED.

5. ANY QUESTIONS REGARDING THIS C.I.E. ALERT SHOULD BE DIRECTED VIA E-MAIL THROUGH THE REGIONAL ANTIDUMPING/COUNTERVAILING DUTY COORDINATOR, TO THE TRADE COMPLIANCE DIVISION, ANTIDUMPING/COUNTERVAILING DUTY BRANCH USING ATTRIBUTE "HQ OAB."
