RE: NOTIFICATION OF PRELIMINARY INJUNCTION ON CERTAIN CASED PENCILS FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-827)

ON 7/14/2004, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON CERTAIN CASED PENCILS FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-827) EXPORTED BY CHINA FIRST PENCIL CO., LTD., ORIENT INTERNATIONAL HOLDING SHANGHAI FOREIGN TRADE CORP., AND SHANGHAI THREE STAR STATIONERY INDUSTRY CORP. FOR THE PERIOD DECEMBER 1, 2001 THROUGH NOVEMBER 30, 2002.

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 04-00242 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED ABOVE THAT REMAIN UNLIQUIDATED AS OF 5:00 PM ON JULY 20, 2004.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WAS EXPORTED BY CHINA FIRST PENCIL CO., LTD., ORIENT INTERNATIONAL HOLDING SHANGHAI FOREIGN TRADE CORP., AND SHANGHAI THREE STAR STATIONERY INDUSTRY CORP. AND WHICH WAS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD DECEMBER 1, 2001 THROUGH NOVEMBER 30, 2002. CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED. ANY ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
