3. AS A RESULT OF COMMERCE'S REVIEW, COMMERCE HAS DETERMINED THAT SHENZHEN CSG AUTOMOTIVE GLASS CO. LTD. IS A SUCCESSOR-IN-INTEREST TO BENXUN AND IS ENTITLED TO RECEIVE BENXUN'S CASH DEPOSIT RATE.
