CHLORINATED ISOCYANURATES FROM SPAIN (A-470-814)

1. ON 06/10/2004, THE DEPARTMENT OF COMMERCE PUBLISHED IN THE FEDERAL REGISTER (69 FR 32488) ITS INITIATION OF AN ANTIDUMPING DUTY INVESTIGATION OF CHLORINATED ISOCYANURATES FROM SPAIN.

2. THE PRODUCTS COVERED BY THIS INVESTIGATION ARE CHLORINATED ISOCYANURATES. CHLORINATED ISOCYANURATES ARE DERIVATIVES OF CYANURIC ACID, DESCRIBED AS CHLORINATED S-TRIAZINE TRIONES. THERE ARE THREE PRIMARY CHEMICAL COMPOSITIONS OF CHLORINATED ISOCYANURATES:

- (1) TRICHLOROISOCYANURIC ACID (CL₃ (NCO)₃),
- (2) SODIUM DICHLOROISOCYANURATE (DIHYDRATE) (NA₂CL₂(NCO)₃ · 2H₂O),
AND
- (3) SODIUM DICHLOROISOCYANURATE (ANHYDROUS) (NA₂CL₂(NCO)₃).

CHLORINATED ISOCYANURATES ARE AVAILABLE IN POWDER, GRANULAR, AND TABLETTED FORMS. THESE INVESTIGATIONS COVER ALL CHLORINATED ISOCYANURATES. CHLORINATED ISOCYANURATES ARE CURRENTLY CLASSIFIABLE UNDER SUBHEADING 2933.69.6050 OF THE HARMONIZED TARIFF SCHEDULE OF THE UNITED STATES (HTSUS). THIS TARIFF CLASSIFICATION REPRESENTS A BASKET CATEGORY THAT INCLUDES CHLORINATED ISOCYANURATES AND OTHER COMPOUNDS INCLUDING AN UNFUSED TRIAZINE RING. ALTHOUGH THE HTSUS SUBHEADING IS PROVIDED FOR CONVENIENCE AND CUSTOMS PURPOSES, THE WRITTEN DESCRIPTION OF THE MERCHANDISE REMAINS DISPOSITIVE.

3. FOR FURTHER REPORTING PURPOSES THIS CASE HAS BEEN ASSIGNED INVESTIGATION NUMBER A-469-814. FOR CBP PURPOSES ONLY THE FOLLOWING IDENTIFICATION NUMBER SHOULD BE USED A-470-814.
