1. THE DEPARTMENT OF COMMERCE PUBLISHED ON AUGUST 10, 1994, THE NOTICE OF THE TERMINATION OF THE ANTIDUMPING DUTY INVESTIGATION OF SST PIPE FITTINGS FROM TAIWAN (A-583-822). THE INVESTIGATION HAS BEEN TERMINATED BECAUSE THE PETITION WAS WITHDRAWN. ALL PARTIES TO THE PROCEEDING HAVE BEEN NOTIFIED AND THE INTERNATIONAL TRADE COMMISSION HAS BEEN CONSULTED. THE DEPARTMENT OF COMMERCE HAS DETERMINED THAT THIS TERMINATION IS IN THE PUBLIC INTEREST.

2. LIQUIDATION INSTRUCTIONS

FIELD OFFICES SHOULD DISCONTINUE SUSPENSION OF LIQUIDATION OF ENTRIES FOR MERCHANDISE ENTERED OR WITHDRAWN FROM THE WAREHOUSE

FOR CONSUMPTION ON OR AFTER MARCH 8, 1994. ALL ESTIMATED ANTIDUMPING DUTIES DEPOSITED ON ENTRIES OF THE SUBJECT MERCHANDISE SHALL BE REFUNDED AND THE BONDS OR OTHER SECURITIES RELEASED AT THE TIME OF LIQUIDATION.

3. INTEREST PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930 DO NOT APPLY.
