1. THIS IS A CORRECTION TO MESSAGE 1342304 DATED 12/08/2011 TO CORRECT PARAGRAPHS ONE AND TWO.

2. PARAGRAPHS 1 AND 2 OF MESSAGE 1342304 CONTAINED INCORRECT INFORMATION ABOUT THE SCOPE OF THE REVOCATION FOR MERCHANDISE MANUFACTURED BY POHANG IRON & STEEL CO., LTD. SPECIFICALLY, THESE PARAGRAPHS STATED THAT THE REVOCATION OF POHANG IRON & STEEL CO., LTD., APPLIED TO MERCHANDISE "MANUFACTURED AND/OR EXPORTED" BY POHANG IRON AND STEEL CO., LTD., WHILE THE REVOCATION ONLY APPLIES TO MERCHANDISE "MANUFACTURED AND EXPORTED" BY POHANG IRON AND STEEL CO., LTD.

PARAGRAPH 1 OF MESSAGE 1342304 READS AS FOLLOWS:

COMMERCE HAS REVOKED THE ANTIDUMPING ORDER ON STAINLESS STEEL SHEET AND STRIP IN COILS FROM THE REPUBLIC OF KOREA IN PART AND PUBLISHED THE REVOCATION IN THE FEDERAL REGISTER ON 12/01/2011. THE PARTIAL REVOCATION APPLIES TO ALL SUBJECT MERCHANDISE MANUFACTURED AND/OR EXPORTED BY POHANG IRON & STEEL CO., LTD. (A-580-834-002); THE EFFECTIVE DATE OF THE REVOCATION IS 11/16/2011.

INSTEAD, PARAGRAPH 1 OF MESSAGE NUMBER 1342304 SHOULD READ AS FOLLOWS:

COMMERCE HAS REVOKED THE ANTIDUMPING ORDER ON STAINLESS STEEL SHEET AND STRIP IN COILS FROM THE REPUBLIC OF KOREA IN PART AND PUBLISHED THE REVOCATION IN THE FEDERAL REGISTER ON 12/01/2011. THE PARTIAL REVOCATION APPLIES TO ALL SUBJECT MERCHANDISE MANUFACTURED AND EXPORTED BY POHANG IRON & STEEL CO., LTD. (A-580-834-002); THE EFFECTIVE DATE OF THE REVOCATION IS 11/16/2011.

PARAGRAPH 2 OF MESSAGE 1342304 READS AS FOLLOWS:

THEREFORE, CBP IS DIRECTED TO TERMINATE THE SUSPENSION OF LIQUIDATION FOR ALL SHIPMENTS OF STAINLESS STEEL SHEET AND STRIP IN COILS FROM THE REPUBLIC OF KOREA WHICH WERE MANUFACTURED AND/OR EXPORTED BY POHANG IRON & STEEL CO., LTD. AND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 11/16/2011. ALL ENTRIES OF STAINLESS STEEL SHEET AND STRIP IN COILS FROM THE REPUBLIC OF KOREA WHICH WERE MANUFACTURED AND/OR EXPORTED BY POHANG IRON & STEEL CO., LTD. AND SUSPENDED ON OR AFTER 11/16/2011 SHOULD BE LIQUIDATED WITHOUT REGARD TO ANTIDUMPING DUTIES (I.E., RELEASE ALL BONDS AND REFUND ALL CASH DEPOSITS).

INSTEAD, PARAGRAPH 1 OF MESSAGE NUMBER 1342304 SHOULD READ AS FOLLOWS:

THEREFORE, CBP IS DIRECTED TO TERMINATE THE SUSPENSION OF LIQUIDATION FOR ALL SHIPMENTS OF STAINLESS STEEL SHEET AND STRIP IN COILS FROM THE REPUBLIC OF KOREA WHICH WERE MANUFACTURED AND EXPORTED BY POHANG IRON & STEEL CO., LTD. AND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 11/16/2011. ALL ENTRIES OF STAINLESS STEEL SHEET AND STRIP IN COILS FROM THE REPUBLIC OF KOREA WHICH WERE MANUFACTURED AND EXPORTED BY POHANG IRON & STEEL CO., LTD. AND SUSPENDED ON OR AFTER 11/16/2011 SHOULD BE LIQUIDATED WITHOUT REGARD TO ANTIDUMPING DUTIES (I.E., RELEASE ALL BONDS AND REFUND ALL CASH DEPOSITS).
