1. ON JULY 29, 2004, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED
A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES
WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON AUTOMOTIVE
REPLACEMENT GLASS WINDSHIELDS FROM THE PEOPLE'S REPUBLIC OF CHINA
(A-570-867), MANUFACTURED OR EXPORTED BY FUYAO GLASS INDUSTRY
GROUP CO., LTD., OR GREENVILLE GLASS INDUSTRIES, INC. FOR THE
PERIOD APRIL 1, 2003, THROUGH MARCH 31, 2004.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE EXPORTED TO OR IMPORTED INTO THE UNITED STATES BY FUYAO GLASS INDUSTRY GROUP CO., LTD., OR GREENVILLE GLASS INDUSTRIES, INC., AND WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD APRIL

1, 2003, THROUGH MARCH 31, 2004, AND WHICH REMAIN UNLIQUIDATED AS OF 5:00 PM ON AUGUST 10, 2004. CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED. ANY ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
