1. THIS IS AN AMENDMENT TO MESSAGE NUMBER 4176209, DATED  
JUNE 24, 2004. PLEASE FOLLOW THE INSTRUCTIONS AS DETAILED BELOW.

2. ON JUNE 26, 2002, THE CIT ISSUED A PRELIMINARY INJUNCTION,  
WHICH ORDERED THE DEPARTMENT TO APPLY A 2.75 PERCENT CASH DEPOSIT  
RATE TO ENTRIES OF FRESHWATER CRAWFISH TAIL MEAT EXPORTED BY  
JIANGSU HILONG INTERNATIONAL TRADING CO., LTD. (JIANGSU HILONG).

DISSOLVED THE PRELIMINARY INJUNCTION AND ORDERED THE DEPARTMENT TO APPLY A CASH DEPOSIT RATE OF 62.77 PERCENT TO ENTRIES OF FRESHWATER CRAWFISH TAIL MEAT EXPORTED BY JIANGSU HILONG. SEE CIT SLIP-OP. 02-135.

3. ENTRIES OF FRESHWATER CRAWFISH TAIL MEAT FROM THE PEOPLE'S REPUBLIC OF CHINA, EXPORTED BY JIANGSU HILONG INTERNATIONAL TRADING CO., LTD. (A-570-848-034) AND ENTERED, OR WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION DURING THE PERIOD SEPTEMBER 1, 2002 THROUGH NOVEMBER 4, 2002, SHOULD BE LIQUIDATED AT THE RATE OF 2.75 PERCENT. ENTRIES OF FRESHWATER CRAWFISH TAIL MEAT FROM THE PEOPLE'S REPUBLIC OF CHINA EXPORTED BY JIANGSU HILONG (A-570-848-034) AND ENTERED, OR WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION DURING THE PERIOD NOVEMBER 5, 2002 THROUGH AUGUST 31, 2003, SHOULD BE LIQUIDATED AT THE RATE OF 62.77 PERCENT. PLEASE NOTE THAT SOME ENTRIES OF MERCHANDISE EXPORTED BY JIANGSU HILONG WHICH ENTERED PRIOR TO NOVEMBER 18, 2002 MAY HAVE ENTERED UNDER THE FOLLOWING CASE SUFFIXES (A-570-848-000) OR (A-570-848-003).

4. ANY ENTRIES WHICH ARE SET FOR LIQUIDATION AT A RATE OTHER THAN THOSE LISTED ABOVE, FOR THE TIME PERIODS LISTED ABOVE, SHOULD BE UNSET IMMEDIATELY, AND LIQUIDATED IN ACCORDANCE WITH THE INSTRUCTIONS ABOVE.
