1. ON 06/16/2004, THE DEPARTMENT OF COMMERCE ISSUED LIQUIDATION INSTRUCTIONS (MESSAGE 4168206) FOR HONEY FROM ARGENTINA (C-357-813) FOR THE PERIOD 03/13/2001, TO 12/31/2002. THIS MESSAGE CLARIFIES PARAGRAPH 4 AND CORRECTS PARAGRAPH 8 OF THAT MESSAGE.

2. PARAGRAPH 4 OF MESSAGE 4168206 APPLIES TO MERCHANDISE ENTERED, OR WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION DURING THE PERIODS

SHOWN. THEREFORE, ENTRIES OF SUBJECT MERCHANDISE MADE ON OR AFTER 03/13/2001, AND ON OR BEFORE 07/10/2001 SHOULD BE ASSESSED

COUNTERVAILING DUTIES AT THE RATE OF 5.77 PERCENT AD VALOREM. ENTRIES OF SUBJECT MERCHANDISE MADE ON OR AFTER 12/11/2001, AND ON OR BEFORE 12/31/2001, SHOULD BE ASSESSED COUNTERVAILING DUTIES AT THE RATE OF 5.77 PERCENT AD VALOREM. ENTRIES OF SUBJECT MERCHANDISE MADE ON OR AFTER 01/01/2002, AND ON OR BEFORE 12/31/2002, SHOULD BE ASSESSED COUNTERVAILING DUTIES AT THE RATE OF 0.57 PERCENT AD VALOREM.

3. PARAGRAPH 8 OF MESSAGE 4168206 SHOULD READ THE SUSPENSION OF LIQUIDATION ORDERED FOR THIS MERCHANDISE EXPORTED ON OR BEFORE 12/31/2002 IS LIFTED. SUSPENSION OF LIQUIDATION FOR THIS MERCHANDISE ENTERED (VERSUS EXPORTED) AFTER 12/31/2002 WILL CONTINUE.
