THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (69 FR 55581) ON 09/15/2004 THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF CERTAIN MANUFACTURERS/EXPORTERS SUBJECT TO THE ANTIDUMPING ORDER ON HAMMERS/SLEDGES FROM THE PEOPLE'S REPUBLIC OF CHINA (PRC) FOR THE PERIOD 02/01/2002 THROUGH 01/31/2003.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES HAVE BEEN REVISED FOR CERTAIN MANUFACTURERS/EXPORTERS. THEREFORE, FOR SHIPMENTS OF HAMMERS/SLEDGES FROM THE PRC ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 09/15/2004, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING MANUFACTURERS/EXPORTERS:

SHANDONG MACHINERY IMPORT + EXPORT CORP.	(A-570-201-002)	0.00

3. IF ANY ENTRIES OF THIS MERCHANDISE ARE EXPORTED BY A FIRM OTHER THAN THE MANUFACTURER, THEN THE FOLLOWING INSTRUCTIONS APPLY:

A. FOR ANY PREVIOUSLY REVIEWED OR INVESTIGATED PRC OR NON-PRC EXPORTER, NOT COVERED IN THIS REVIEW, WITH A SEPARATE RATE, THE CASH DEPOSIT RATE WILL BE THE COMPANY-SPECIFIC RATE ESTABLISHED IN THE MOST RECENT SEGMENT OF THIS PROCEEDING.

C. THE CASH DEPOSIT RATE FOR ANY NON-PRC EXPORTER OF SUBJECT HAMMERS/SLEDGES FROM THE PRC WHO DOES NOT HAVE ITS OWN RATE WILL BE THE RATE APPLICABLE TO THE PRC MANUFACTURER/EXPORTER THAT SUPPLIED THE NON-PRC EXPORTER.

4. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS FOR THE NEXT ADMINISTRATIVE REVIEW. DO NOT LIQUIDATE ANY ENTRIES COVERED BY THIS REVIEW UNTIL YOU HAVE RECEIVED LIQUIDATION INSTRUCTIONS.
