IN THE REFERENCED E-MAIL ITEM #3 INADVERTENTLY STATED THAT ANY ENTRIES OF CORROSION-RESISTANT CARBON STEEL FLAT PRODUCTS FROM FRANCE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION, ON OR AFTER DECEMBER 7, 1992, BUT PRIOR TO APRIL 6, 1993 SHOULD NOT BE LIQUIDATED. IN ADDITION, IT STATED THAT ANY ENTRIES OF THESE PRODUCTS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION, ON OR AFTER AUGUST 17, 1993 SHOULD NOT BE LIQUIDATED.

2. ITEM #3 OF THE REFERENCED E-MAIL SHOULD READ, IN ITS ENTIRETY, DO NOT LIQUIDATE ANY ENTRIES OF CORROSION-RESISTANT CARBON STEEL FLAT PRODUCTS FROM FRANCE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION, ON OR AFTER DECEMBER 7, 1992.
