ON 09/27/2004, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER OR FINDING ON CERTAIN PRESERVED MUSHROOMS FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-851), MANUFACTURED OR EXPORTED BY GERBER FOOD (YUNNAN) CO., LTD. (A-570-851-004) AND GREEN FRESH FOODS (ZHANGZHOU) CO., LTD. (A-570-851-015) FOR THE PERIOD 02/01/2002 THROUGH

01/31/2003.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WAS PRODUCED OR EXPORTED BY GERBER

FOOD (YUNNAN) CO., LTD. (A-570-851-004) AND GREEN FRESH FOODS (ZHANGZHOU) CO., LTD. (A-570-851-015) AND WHICH WAS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 02/01/2002 THROUGH 01/31/2003 WHICH REMAIN UNLIQUIDATED AS OF 5:00 P.M. ON 10/06/2004. CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED. ANY ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
