RE: REVOCATION OF ANTIDUMPING DUTY ORDER ON BULK ASPIRIN  
FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-853)

1. AS A RESULT OF THE DEPARTMENT'S DETERMINATION THAT THE PETITIONER, RHODIA INC., IS NO LONGER INTERESTED IN THE RELIEF PROVIDED BY THE ANTIDUMPING DUTY ORDER ON BULK ASPIRIN FROM THE PEOPLE'S REPUBLIC OF CHINA ("PRC"), THE DEPARTMENT OF COMMERCE HAS REVOKED THIS ANTIDUMPING DUTY ORDER AND PUBLISHED THE REVOCATION IN THE FEDERAL REGISTER ON 12/28/2004 (69 FR 77726). THE EFFECTIVE DATE OF THIS REVOCATION IS 07/01/2003.

2. THEREFORE, CBP IS DIRECTED TO TERMINATE THE SUSPENSION OF

LIQUIDATION FOR ALL SHIPMENTS OF BULK ASPIRIN ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 07/01/2003. ALL ENTRIES OF THE SUBJECT PRODUCT THAT WERE SUSPENDED ON OR AFTER 07/01/2003 SHOULD BE LIQUIDATED WITHOUT REGARD TO ANTIDUMPING DUTIES (I.E., RELEASE ALL BONDS AND REFUND ALL CASH DEPOSITS).

3. PURSUANT TO MESSAGE NUMBERS 4188205 AND 4188206, BOTH DATED 07/06/2004, THE DEPARTMENT REVOKED THE ANTIDUMPING DUTY ORDER WITH RESPECT TO SHANDONG XINHUA PHARMACEUTICAL CO., LTD. ("SHANDONG") (A-570-853-002), AND DIRECTED CUSTOMS AND BORDER PROTECTION TO TERMINATE THE SUSPENSION OF LIQUIDATION FOR ALL SHIPMENTS OF BULK ASPIRIN FROM THE PRC MANUFACTURED AND EXPORTED BY SHANDONG ON OR AFTER 06/22/2004. THEREFORE, THIS MESSAGE APPLIES TO ALL OTHER COMPANIES (A-570-853-000 AND A-570-853-001) AND ENTRIES ON OR AFTER 07/01/2003.

4. THE ASSESSMENT OF ANTIDUMPING DUTIES BY CUSTOMS AND BORDER PROTECTION ON ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT 1930. SECTION 778 REQUIRES THAT CBP PAYS INTEREST ON OVERPAYMENTS AND ASSESS INTEREST ON UNDERPAYMENTS OF THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED ANTIDUMPING DUTIES. THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED ANTIDUMPING DUTIES BEFORE THE DATE OF PUBLICATION OF THE ANTIDUMPING DUTY ORDER ON 07/11/2000 (65 FR 42673). INTEREST SHALL BE CALCULATED FROM THE DATE OF PAYMENT OF ESTIMATED ANTIDUMPING DUTIES THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.

5.
