1. THE DEPARTMENT OF COMMERCE HAS AMENDED THE FINAL DETERMINATION IN THE COUNTERVAILING DUTY INVESTIGATION OF CERTAIN SOFTWOOD LUMBER PRODUCTS FROM CANADA, EFFECTIVE 12/10/2004. THE NOTICE OF IMPLEMENTATION UNDER SECTION 129 OF THE URUGUAY ROUND AGREEMENTS ACT WILL PUBLISH IN THE FEDERAL REGISTER ON OR ABOUT 12/15/2004.

2. FOR SHIPMENTS OF CERTAIN SOFTWOOD LUMBER PRODUCTS FROM CANADA, ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 12/10/2004, THE AMENDED CASH DEPOSIT REQUIREMENT FOR ALL COMPANIES OTHER THAN THOSE WITH A COMPANY-SPECIFIC RATE IS AS FOLLOWS:
