1. ON 12/29/2004, THE DEPARTMENT OF COMMERCE WILL PUBLISH IN THE
FEDERAL REGISTER ITS COUNTERVAILING DUTY ORDER IN THE
INVESTIGATION OF CARBAZOLE VIOLET PIGMENT 23.

2. FOR PURPOSES OF THIS INVESTIGATION, CVP-23 IS IDENTIFIED AS
COLOR INDEX NO. 51319 AND CHEMICAL ABSTRACT NO. 6358-30-1, WITH
THE CHEMICAL NAME OF DIINDOLO (3,2-b:3',2'-M)TRIPHENODIOXAZINE,
8,18-DICHLORO-5, 155,15-DIETHY-5,15-DIHYDRO-, AND MOLECULAR

FORMULA OF C₃₄H₂₂Cl₂N₄O₂. THE SUBJECT MERCHANDISE INCLUDES THE CRUDE PIGMENT IN ANY FORM (E.G., DRY POWDER, PASTE, WET CAKE) AND FINISHED PIGMENT IN THE FORM OF PRESSCAKE AND DRY COLOR. PIGMENT DISPERSIONS IN ANY FORM (E.G., PIGMENTS DISPERSED IN OLEORESINS, FLAMMABLE SOLVENTS, WATER) ARE NOT INCLUDED WITHIN THE SCOPE OF THE INVESTIGATION.

CVP-23 IS CURRENTLY CLASSIFIABLE UNDER SUBHEADING 3204.17.9040 OF THE HARMONIZED TARIFF SCHEDULE OF THE UNITED STATES (HTSUS). ALTHOUGH THE HTSUS SUBHEADINGS ARE PROVIDED FOR CONVENIENCE AND CUSTOMS PURPOSES, THE WRITTEN DESCRIPTION OF THE MERCHANDISE UNDER INVESTIGATION IS DISPOSITIVE.

3. FOR FURTHER REPORTING PURPOSES THIS CASE HAS BEEN ASSIGNED INVESTIGATION NUMBER C-533-839.

4. FOR IMPORTS OF CARBAZOLE VIOLET PIGMENT 23 (CVP-23) FROM INDIA, CUSTOMS AND BORDER PROTECTION SHALL SUSPEND LIQUIDATION OF SUCH SHIPMENTS ENTERED OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 12/28/2004. EFFECTIVE 12/28/2004 CBP SHALL REQUIRE A CASH DEPOSIT EQUAL TO THE SUBSIDY RATES SHOWN BELOW:
