1. ON APRIL 19, 1994, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE COUNTERVAILING DUTY ORDER ON HOT-ROLLED LEAD AND BISMUTH STEEL PRODUCTS FROM FRANCE ENTERED ON OR AFTER SEPTEMBER 17, 1992 (C-427-805), MANUFACTURED OR EXPORTED BY USINOR SACILOR, UNIMETAL AND ASCOMETAL (COLLECTIVELY "USINOR SACILOR"). SEPARATE INSTRUCTIONS HAVE BEEN ISSUED FOR ENTRIES SUBJECT TO THE CONCURRENT ANTIDUMPING DUTY ORDER.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE PRODUCED OR EXPORTED BY USINOR SACILOR AND WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER SEPTEMBER 17, 1992.

3. IF THERE ARE ANY QUESTIONS REGARDING THIS MATTER BY CUSTOMS OFFICERS, THEY SHOULD CONTACT VIA EMAIL, THROUGH THE REGIONAL ANTIDUMPING/COUNTERVAILING DUTY COORDINATOR, TRADE COMPLIANCE DIVISION, ANTIDUMPING/COUNTERVAILING DUTY BRANCH USING ATTRIBUTE "HQ OAB".
