RE: SCOPE RULING ON ANTIDUMPING DUTY ORDER ON PORCELAIN-ON- STEEL COOKING WARE FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-506)

1. ON JANUARY 4, 2005, IN RESPONSE TO A REQUEST BY TAYBEK INTERNATIONAL, THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE RULING THAT THE PRO POPPER(TM) PROFESSIONAL POPCORN POPPER IS WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING PORCELAIN-ON-STEEL COOKING WARE FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-506).

2. BECAUSE THE IMPORTED PRODUCT IS COMPOSED OF A STEEL VESSEL

ENAMELED WITH PORCELAIN ON ITS EXTERIOR SURFACE AND IS INTENDED FOR COOKING FOOD ON THE STOVE TOP, THE DEPARTMENT OF COMMERCE FOUND THIS PRODUCT TO BE WITHIN THE SCOPE OF THE ORDER.

3. CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF PORCELAIN-ON-STEEL COOKING WARE FROM THE PEOPLE'S REPUBLIC OF CHINA, INCLUDING TAYBEK INTERNATIONAL'S PRO POPPER(TM) PROFESSIONAL POPCORN POPPER, LISTED ABOVE, SUBJECT TO THE ANTIDUMPING DUTY ORDER COVERING PORCELAIN-ON-STEEL COOKING WARE FROM THE PEOPLE'S REPUBLIC OF CHINA.
