DUTY INVESTIGATION OF PURIFIED CARBOXYMETHYLCELLULOSE
FROM FINLAND (A-405-803)

1. ON 12/27/2004, THE DEPARTMENT OF COMMERCE WILL PUBLISH IN THE FEDERAL REGISTER ITS PRELIMINARY DETERMINATION OF SALES AT LESS THAN FAIR VALUE AND THE POSTPONEMENT OF THE FINAL DETERMINATION IN THE ANTIDUMPING DUTY INVESTIGATION OF PURIFIED CARBOXYMETHYLCELLULOSE FROM FINLAND.

2. FOR PURPOSES OF THESE INVESTIGATIONS, THE PRODUCTS COVERED ARE ALL PURIFIED CARBOXYMETHYLCELLULOSE (CMC), SOMETIMES ALSO REFERRED TO AS PURIFIED SODIUM CMC, POLYANIONIC CELLULOSE, OR

CELLULOSE GUM, WHICH IS A WHITE TO OFF-WHITE, NON-TOXIC, ODORLESS, BIODEGRADABLE POWDER, COMPRISING SODIUM CARBOXYMETHYLCELLULOSE THAT HAS BEEN REFINED AND PURIFIED TO A MINIMUM ASSAY OF 90 PERCENT. PURIFIED CMC DOES NOT INCLUDE UNPURIFIED OR CRUDE CMC, CMC FLUIDIZED POLYMER SUSPENSIONS, AND CMC THAT IS CROSS-LINKED THROUGH HEAT TREATMENT. PURIFIED CMC IS CMC THAT HAS UNDERGONE ONE OR MORE PURIFICATION OPERATIONS WHICH,

AT A MINIMUM, REDUCE THE REMAINING SALT AND OTHER BY-PRODUCT PORTION OF THE PRODUCT TO LESS THAN TEN PERCENT.

THE MERCHANDISE SUBJECT TO THIS INVESTIGATION IS CLASSIFIED IN THE HARMONIZED TARIFF SCHEDULE OF THE UNITED STATES AT SUBHEADING 3912.31.00. THIS TARIFF CLASSIFICATION IS PROVIDED FOR CONVENIENCE AND CUSTOMS PURPOSES; HOWEVER, THE WRITTEN DESCRIPTION OF THE SCOPE OF THESE INVESTIGATIONS IS DISPOSITIVE.

3. FOR FURTHER REPORTING PURPOSES THIS CASE HAS BEEN ASSIGNED INVESTIGATION NUMBER A-405-803.

4. FOR IMPORTS OF PURIFIED CARBOXYMETHYLCELLULOSE FROM FINLAND, THE BUREAU OF CUSTOMS AND BORDER PROTECTION (CBP) SHALL SUSPEND LIQUIDATIONS OF SUCH SHIPMENTS ENTERED OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 12/27/2004. CBP SHALL REQUIRE, FOR SUCH ENTRIES, A CASH DEPOSIT OR THE POSTING OF A BOND EQUAL TO THE MARGIN SHOWN BELOW:

5. IN ACCORDANCE WITH T.D. 85-145, AT THE DISCRETION OF THE CUSTOMS SERVICE, CUSTOMS OFFICERS MAY ACCEPT EITHER A SINGLE-ENTRY BASIC IMPORTATION AND ENTRY BOND OR A CONTINUOUS BASIC

INFORMATION AND ENTRY BOND ONLY IF THE AMOUNT OF THE ESTIMATED ANTIDUMPING OR COUNTERVAILING DUTY IS LESS THAN FIVE PERCENT AD VALOREM (OR THE EQUIVALENT). OTHERWISE, WHERE THE IMPORTER HAS THE OPTION TO POST A BOND FOR ESTIMATED ANTIDUMPING OR COUNTERVAILING DUTIES, CUSTOMS OFFICERS MUST REQUIRE A SINGLE-ENTRY BASIC IMPORTATION AND ENTRY BOND PURSUANT TO T.D. 85-145. YOU ARE INSTRUCTED TO ADHERE TO THE REQUIREMENTS OF T.D. 85-145 WITH RESPECT TO THESE BONDING REQUIREMENTS.
