RE: SCOPE RULING ON ANTIDUMPING DUTY ORDER ON PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-504)

1. ON DECEMBER 22, 2004, IN RESPONSE TO A REQUEST BY DOLLAR TREE STORES INC., THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE RULING THAT THREE GEL CANDLES (ALL WITH SKU 162394) ARE WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-504).

2. BECAUSE THE IMPORTED PRODUCTS ARE INDEED PETROLEUM WAX CANDLES

AND NONE OF THESE CANDLES FULFILL THE REQUIREMENTS FOR THE

IDENTIFIABLE OBJECT AND/OR HOLIDAY NOVELTY CANDLE EXCEPTION, THE COMMERCE DEPARTMENT FOUND THESE PRODUCTS TO BE WITHIN THE SCOPE OF THE ORDER.

3. CONTINUE TO SUSPEND LIQUIDATION OF, AND COLLECT CASH DEPOSITS ON, ENTRIES OF PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA, INCLUDING DOLLAR TREE'S THREE GEL CANDLES (ALL WITH SKU 162394), AS LISTED ABOVE, SUBJECT TO THE ANTIDUMPING DUTY ORDER COVERING PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA.
