1. ON JANUARY 4, 2005, THE DEPARTMENT OF COMMERCE PUBLISHED IN THE FEDERAL REGISTER ITS ANTIDUMPING DUTY ORDER IN THE INVESTIGATION OF WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA.

2. THE DEPARTMENT OF COMMERCE FOUND THAT A DE MINIMIS MARGIN OF 0.83 PERCENT EXISTS WITH RESPECT TO IMPORTS OF WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA WHICH WAS

MANUFACTURED AND EXPORTED BY MARKOR INTERNATIONAL FURNITURE (TIANJIN) MANUFACTURE CO., LTD. (A-570-890-004). ACCORDINGLY, FOR WOODEN BEDROOM FURNITURE MANUFACTURED AND EXPORTED BY MARKOR

INTERNATIONAL FURNITURE (TIANJIN) MANUFACTURE CO., LTD., U.S. CUSTOMS AND BORDER PROTECTION ("CBP") IS DIRECTED TO TERMINATE THE SUSPENSION OF LIQUIDATION FOR SHIPMENTS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER JUNE 24, 2004, AND TO RELEASE ANY BOND OR OTHER SECURITY AND REFUND ANY CASH DEPOSIT.

3. INTEREST PROVISIONS OF SECTION 778 OF THE ACT DO NOT APPLY.
