RE: SCOPE RULING ON ANTIDUMPING DUTY ORDER ON PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-504)

1. ON 1/26/2005, IN RESPONSE TO A REQUEST BY DOLLAR TREE STORES, INC. (DOLLAR TREE), THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE RULING THAT THE FOLLOWING DOLLAR TREE CANDLES: MOLDED "FLOWER BUD" CANDLE PURPLE (SKU 806825), MOLDED "FLOWER BUD" CANDLE - MAGENTA (SKU 806825), MOLDED "FLOWER BUD" CANDLE - LIGHT MAGENTA (SKU 806825), MOLDED "FLOWER BUD" CANDLE - AQUA GREEN (SKU 806825), MOLDED "BUTTERFLY" CANDLE - YELLOW (SKU 806825),

THREE DIFFERENT "ASSORTED AUTUMN LEAVES" FLOATER CANDLE SETS (ALL

WITH SKU 813804), WHICH CONTAIN THREE CANDLES, IN ALTERNATING HUES OF RED, GREEN, AND ORANGE, "CHRISTMAS" FLOATER CANDLE - SNOWMAN HEAD (SKU 130660), "CHRISTMAS" FLOATER CANDLE - RED POINSETTIA (SKU 130660), "CHRISTMAS" FLOATER CANDLE - HOLLY LEAF WITH RED BERRIES (SKU 130660), "CHRISTMAS" FLOATER CANDLE - MOLDED WHITE SNOWFLAKE (SKU 130660), MOLDED "FLOWER BUD" CANDLE - ORANGE (SKU 806827), MOLDED "FLOWER BUD" CANDLE - GREEN (SKU 806827), MOLDED "FLOWER BUD" CANDLE - BLUE (SKU 806827) AND " BUTTERFLY" FLOATER CANDLE (SKU 806827) ARE WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-504).

2. BECAUSE THE IMPORTED PRODUCTS DO NOT FULFILL THE REQUIREMENTS FOR THE DEPARTMENT'S JULY 1987 NOVELTY AND/OR HOLIDAY CANDLE EXCEPTION, THE COMMERCE DEPARTMENT FOUND THESE PRODUCTS TO BE WITHIN THE SCOPE OF THE ORDER.

3. CONTINUE TO SUSPEND LIQUIDATION OF, AND COLLECT CASH DEPOSITS ON, ENTRIES OF PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA, FOR DOLLAR TREE'S CANDLES LISTED ABOVE, SUBJECT TO THE ANTIDUMPING DUTY ORDER ON PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA.

4. FOR ALL SHIPMENTS OF PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA, INCLUDING THE ABOVE-NOTED CANDLES IMPORTED BY DOLLAR TREE LISTED IN PARAGRAPH 1, YOU SHALL, UNLESS OTHERWISE INSTRUCTED, CONTINUE TO ASSESS ANTIDUMPING DUTIES ON THE SUBJECT MERCHANDISE AS INSTRUCTED BY THE DEPARTMENT OF COMMERCE.
