RE: SCOPE RULING ON ANTIDUMPING DUTY ORDER ON PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-504)

1. ON 1/14/2005, IN RESPONSE TO A REQUEST BY SPECIALTY MERCHANDISE CORP.(SPECIALTY MERCHANDISE), THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE RULING THAT THE FOLLOWING SPECIALTY MERCHANDISE CANDLE, "XMAS JOY CANDLE" WITH METAL STAND (PRODUCT PROFILE NUMBER 31427), IS WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING PETROLEUM WAX CANDLES FROM THE

PEOPLE'S REPUBLIC OF CHINA (A-570-504).

2. BECAUSE THE IMPORTED PRODUCT DOES NOT FULFILL THE REQUIREMENTS FOR THE DEPARTMENT'S JULY 1987 NOVELTY AND/OR HOLIDAY CANDLE EXCEPTION, THE COMMERCE DEPARTMENT FOUND THIS PRODUCT TO BE WITHIN THE SCOPE OF THE ORDER.

3. CBP IS INSTRUCTED TO CONTINUE TO SUSPEND LIQUIDATION OF, AND COLLECT CASH DEPOSITS ON, ENTRIES OF PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA, FOR SPECIALTY MERCHANDISE'S "XMAS JOY CANDLE" WITH METAL STAND (PRODUCT PROFILE NUMBER 31427) LISTED ABOVE, SUBJECT TO THE ANTIDUMPING DUTY ORDER ON PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA.

4. FOR ALL SHIPMENTS OF PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA, INCLUDING THE ABOVE-NOTED CANDLE IMPORTED BY SPECIALTY MERCHANDISE LISTED IN PARAGRAPH 1, YOU SHALL, UNLESS OTHERWISE INSTRUCTED, CONTINUE TO ASSESS ANTIDUMPING DUTIES ON THE SUBJECT MERCHANDISE AS INSTRUCTED BY THE DEPARTMENT OF COMMERCE
