RE: SCOPE RULING ON ANTIDUMPING DUTY ORDER ON PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-504)

1. ON 1/14/2005, IN RESPONSE TO A REQUEST BY NOTEWORTHY, A DIVISION OF PAPERMATES, INC., (NOTEWORTHY), THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE RULING THAT THE FOLLOWING NOTEWORTHY CANDLES, "FLOATER FLOWER CANDLE" (PRODUCT PROFILE NUMBER 80416) AND "ROSE PILLAR CANDLE" (PRODUCT PROFILE NUMBER 80417), ARE WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-504).

2. BECAUSE THE IMPORTED PRODUCTS DO NOT FULFILL THE REQUIREMENTS FOR THE DEPARTMENT'S JULY 1987 NOVELTY AND/OR HOLIDAY CANDLE EXCEPTION, THE COMMERCE DEPARTMENT FOUND THESE PRODUCTS TO BE WITHIN THE SCOPE OF THE ORDER.

3. CBP IS INSTRUCTED TO CONTINUE TO SUSPEND LIQUIDATION OF, AND COLLECT CASH DEPOSITS ON, ENTRIES OF PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA, FOR NOTEWORTHY'S "FLOATER FLOWER CANDLE" (PRODUCT PROFILE NUMBER 80416) AND "ROSE PILLAR CANDLE" (PRODUCT PROFILE NUMBER 80417) LISTED ABOVE, SUBJECT TO THE ANTIDUMPING DUTY ORDER ON PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA.

4. FOR ALL SHIPMENTS OF PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA, INCLUDING THE ABOVE-NOTED CANDLES IMPORTED BY NOTEWORTHY LISTED IN PARAGRAPH 1, YOU SHALL, UNLESS OTHERWISE INSTRUCTED, CONTINUE TO ASSESS ANTIDUMPING DUTIES ON THE SUBJECT MERCHANDISE AS INSTRUCTED BY THE DEPARTMENT OF COMMERCE.
