RE: SCOPE RULING ON ANTIDUMPING DUTY ORDER ON PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-504)

1. ON 12/17/2004, IN RESPONSE TO A REQUEST BY WAL-MART STORES, INC. (WAL-MART), THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE RULING THAT THE FOLLOWING WAL-MART CANDLES: "CHRISTMAS TREE BALL ORNAMENT" CANDLES (STYLE SC02-319), "SNOWBALL" CANDLES (STYLE SC02-320), "SNOWBALL" CANDLE IN CLEAR GOBLET (STYLE SC02-325), " SNOWBALL" CANDLE IN RED GOBLET (STYLE SC02-328) ARE WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-504).

2. BECAUSE THE IMPORTED PRODUCTS DO NOT FULFILL THE REQUIREMENTS FOR THE DEPARTMENT'S JULY 1987 IDENTIFIABLE OBJECT AND/OR HOLIDAY NOVELTY CANDLE EXCEPTION, THE COMMERCE DEPARTMENT FOUND THESE PRODUCTS TO BE WITHIN THE SCOPE OF THE ORDER.

3. CONTINUE TO SUSPEND LIQUIDATION OF, AND COLLECT CASH DEPOSITS ON, ENTRIES OF PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA, FOR THE FOLLOWING WAL-MART CANDLES: "CHRISTMAS TREE BALL ORNAMENT" CANDLES (STYLE SC02-319), "SNOWBALL" CANDLES (STYLE SC02-320), "SNOWBALL" CANDLE IN CLEAR GOBLET (STYLE SC02-325), "SNOWBALL" CANDLE IN RED GOBLET (STYLE SC02-328) , SUBJECT TO THE ANTIDUMPING DUTY ORDER ON PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA.
