RE: SCOPE RULING ON ANTIDUMPING DUTY ORDER ON PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-504)

1. ON 12/16/2004, IN RESPONSE TO A REQUEST BY ATICO INTERNATIONAL USA, INC. (ATICO), THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE RULING THAT ATICO'S "WAX ICON" (ITEM NUMBER W72L2153), "SANTA ORNAMENT" (ITEM NUMBER C-74-Q-2073), "CANDY CORN" (ITEM NUMBER C79H-0517), AND "CHRISTMAS PILLAR" (ITEM NUMBER W72L2060) CANDLES ARE ALL WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING PETROLEUM WAX CANDLES FROM THE

PEOPLE'S REPUBLIC OF CHINA (A-570-504).

2. BECAUSE THE IMPORTED PRODUCTS DO NOT FULFILL THE REQUIREMENTS FOR THE DEPARTMENT'S JULY 1987 NOVELTY AND/OR HOLIDAY CANDLE EXCEPTION, THE COMMERCE DEPARTMENT FOUND THESE PRODUCTS TO BE WITHIN THE SCOPE OF THE ORDER.

3. CONTINUE TO SUSPEND LIQUIDATION OF, AND COLLECT CASH DEPOSITS ON, ENTRIES OF PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA, FOR ATICO'S "WAX ICON" (ITEM NUMBER W72L2153) , "SANTA ORNAMENT" (ITEM NUMBER C-74-Q-2073), "CANDY CORN" (ITEM NUMBER C79H-0517), AND "CHRISTMAS PILLAR" (ITEM NUMBER W72L2060) CANDLES, SUBJECT TO THE ANTIDUMPING DUTY ORDER ON PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA.

4. FOR ALL SHIPMENTS OF PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA, INCLUDING THE ABOVE-NOTED CANDLES IMPORTED BY ATICO LISTED IN PARAGRAPH 1, YOU SHALL, UNLESS OTHERWISE INSTRUCTED, CONTINUE TO ASSESS ANTIDUMPING DUTIES ON THE SUBJECT MERCHANDISE AS INSTRUCTED BY THE DEPARTMENT OF COMMERCE.
