1. THE C.I.T. HAS ISSUED A STAY OF LIQUIDATION PENDING APPEAL WITH REGARD TO ENTRIES OF CERAMIC TILE FROM MEXICO MANUFACTURED BY CERAMICA REGION MANTANA, S.A., CERAMICA Y PISOS INDUSTRIALES DE CULICAN, S.A. AND INDUSTRIALES INTERCONTINENTAL, S.A. AND COVERED BY THE ADMINISTRATIVE REVIEW (54 FED. REG. 19930 (1989), COVERING ENTRIES FROM JANUARY 1, 1986 THROUGH DECEMBER 31, 1986.

2. THEREFORE, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE SHIPMENTS OF CERAMIC TILE FROM MEXICO THAT WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD JANUARY 1, 1986 THROUGH DECEMBER 31, 1986 THAT WERE PRODUCED BY THE FOREMENTIONED FIRMS, AND WHICH REMAIN UNLIQUIDATED AT THE CLOSE OF BUSINESS ON JANUARY 27, 1995.
