RE: NOTIFICATION OF TERMINATION OF THE ANTIDUMPING DUTY INVESTIGATION OF CERTAIN CIRCULAR WELDED CARBON QUALITY LINE PIPE FROM KOREA (A-580-854)

1. ON 02/17/2005, THE DEPARTMENT OF COMMERCE PUBLISHED IN THE FEDERAL REGISTER (70 FR 8071) NOTICE OF THE TERMINATION OF THE ANTIDUMPING DUTY INVESTIGATION OF CERTAIN CIRCULAR WELDED CARBON QUALITY LINE PIPE FROM KOREA. THE INVESTIGATION HAS BEEN TERMINATED BECAUSE THE PETITION WAS WITHDRAWN. ALL PARTIES TO THE PROCEEDING HAVE BEEN NOTIFIED AND THE INTERNATIONAL TRADE COMMISSION HAS BEEN CONSULTED. THE DEPARTMENT OF COMMERCE HAS DETERMINED THAT THIS TERMINATION IS IN THE PUBLIC INTEREST.

2. FIELD OFFICES SHOULD DISCONTINUE SUSPENSION OF LIQUIDATION OF SHIPMENTS OF MERCHANDISE ENTERED OR WITHDRAWN FROM THE WAREHOUSE FOR CONSUMPTION ON OR AFTER OCTOBER 6, 2004. ALL ESTIMATED ANTIDUMPING DUTIES DEPOSITED ON ENTRIES OF THE SUBJECT MERCHANDISE SHALL BE REFUNDED AND THE BONDS OR OTHER SECURITY RELEASED AT THE TIME OF LIQUIDATIONS.

3. INTEREST PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930 DO NOT APPLY.
