RE: SCOPE RULING ON ANTIDUMPING DUTY ORDER ON PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-504)

1. ON 1/19/2005, IN RESPONSE TO A REQUEST BY KATHRYN BEICH, INC., THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE RULING THAT KATHRYN BEICH'S "JEWEL" CANDLE, "RED ROSE" CANDLE, AND "POLKA DOT" CANDLE ARE WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC

OF CHINA (A-570-504).

2. BECAUSE THE DEPARTMENT DID NOT FIND SUFFICIENT EVIDENCE ON

THE RECORD TO ESTABLISH THAT THESE CANDLES SHOULD BE EXCLUDED BECAUSE OF THEIR ALLEGED PALM OIL CONTENT, THE COMMERCE DEPARTMENT FOUND THESE PRODUCTS TO BE WITHIN THE SCOPE OF THE ORDER.

3. CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA, INCLUDING KATHRYN BEICH'S "JEWEL" CANDLE, "RED ROSE" CANDLE, AND "POLKA DOT" CANDLE LISTED ABOVE, SUBJECT TO THE ANTIDUMPING DUTY ORDER COVERING PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA.
