1. ON FEBRUARY 8, 2005, THE DEPARTMENT OF COMMERCE PUBLISHED IN THE FEDERAL REGISTER (70 FR 6618) ITS FINAL RESULTS OF THE ANTIDUMPING DUTY ADMINISTRATIVE REVIEW ON IQF RED RASPBERRIES FROM CHILE FOR THE PERIOD 12/31/2001 THROUGH 06/30/2003 (A-337-806).

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATE HAS BEEN REVISED FOR CERTAIN MANUFACTURERS/EXPORTERS. FOR ALL SHIPMENTS OF IQF RED RASPBERRIES FROM CHILE ENTERED, OR

WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 07/01/2003, THE REQUIRED CASH DEPOSIT RATE HAS BEEN REVISED FOR THE FOLLOWING MANUFACTURERS/EXPORTERS:
