1. THIS MESSAGE REPLACES PRELIMINARY INJUNCTION INSTRUCTIONS MESSAGE #4365204 DATED 12/30/2004. ON 3/9/2005, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED AN AMENDED PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON BALL BEARINGS AND PARTS THEREOF FROM JAPAN PRODUCED OR EXPORTED BY KOYO SEIKO CO., LTD., AND IMPORTED BY KOYO CORPORATION U.S.A. (A-588-201-005) FOR THE PERIOD 5/1/2002 THROUGH 4/30/2003.

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 04-00530 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED ABOVE.
3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE PRODUCED OR EXPORTED FROM JAPAN BY KOYO SEIKO CO., LTD., IMPORTED BY KOYO CORPORATION U.S.A., AND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 5/1/2002 THROUGH 4/30/2003. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.
4. LIQUIDATION INSTRUCTIONS FOR ENTRIES AFFECTED BY THIS INJUNCTION HAVE NOT YET BEEN ISSUED.
5. THESE INSTRUCTIONS TAKE EFFECT IMMEDIATELY.
6. THE DEPARTMENT OF COMMERCE WAS SERVED WITH THE ABOVE-REFERENCED INJUNCTION ON 3/15/2005. PURSUANT TO THE TERMS OF THE INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS OF THE ACTUAL ORDER DATE OF THE INJUNCTION (3/9/2005).
