RE: REVOCATION OF ANTIDUMPING DUTY ORDER IN PART ON CERTAIN PASTA FROM ITALY (A-475-818) MANUFACTURED AND EXPORTED BY PASTA LENSI S.R.L.

1. THE DEPARTMENT OF COMMERCE HAS REVOKED THE ANTIDUMPING DUTY ORDER ON CERTAIN PASTA FROM ITALY IN PART AND PUBLISHED THE REVOCATION IN THE FEDERAL REGISTER ON 02/09/2005. THE PARTIAL REVOCATION APPLIES TO ALL SUBJECT MERCHANDISE MANUFACTURED AND EXPORTED BY PASTA LENSI S.R.L. AND THE EFFECTIVE DATE OF THE REVOCATION IS 07/01/2002.

2. THEREFORE, CBP IS DIRECTED TO TERMINATE THE SUSPENSION OF LIQUIDATION FOR ALL SHIPMENTS OF CERTAIN PASTA MANUFACTURED BY

PASTA LENSI S.R.L. ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 07/01/2002. ALL ENTRIES OF THE SUBJECT PRODUCT MANUFACTURED BY PASTA LENSI S.R.L. THAT WERE SUSPENDED ON OR AFTER 07/01/2002 SHOULD BE LIQUIDATED WITHOUT REGARD TO ANTIDUMPING DUTIES (I.E., RELEASE ALL BONDS AND REFUND ALL CASH DEPOSITS).

3. THE ASSESSMENT OF ANTIDUMPING DUTIES BY CUSTOMS AND BORDER PROTECTION (CBP) ON ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930. SECTION 778 REQUIRES THAT CBP PAYS INTEREST ON OVERPAYMENTS AND ASSESS INTEREST ON UNDERPAYMENTS OF THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED ANTIDUMPING DUTIES. THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED ANTIDUMPING DUTIES BEFORE THE DATE OF PUBLICATION OF THE ANTIDUMPING DUTY ORDER. INTEREST SHALL BE CALCULATED FROM THE DATE OF PAYMENT OF ESTIMATED ANTIDUMPING DUTIES THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.
