1. ON 02/18/2005, THE U.S. COURT OF APPEALS FOR THE FEDERAL
CIRCUIT ISSUED AN INJUNCTION PENDING APPEAL ENJOINING
LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE
ANTIDUMPING DUTY ORDER ON STAINLESS STEEL BAR FROM ITALY
(A-475-829), MANUFACTURED AND/OR EXPORTED BY ACCIAIERIE
VALBRUNA, S.P.A. ("VALBRUNA") FOR THE PERIOD 01/23/2002
THROUGH 02/29/2004.

2. THE INJUNCTION PENDING APPEAL WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 04-1535, AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED ABOVE.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE PRODUCED AND/OR EXPORTED BY VALBRUNA AND WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 01/23/2002 THROUGH 02/29/2004. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED. ANY ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.

4. LIQUIDATION INSTRUCTIONS FOR ENTRIES AFFECTED BY THIS INJUNCTION HAVE NOT YET BEEN ISSUED.

5. THESE INSTRUCTIONS TAKE EFFECT IMMEDIATELY.
