RE: INJUNCTION ON HEAVY FORGED HAND TOOLS FOR TIANJIN MACHINERY AND SHANDONG HUARONG-CHINA (CT NO 02-00637) (A-570-201, A-570-202, A-570-203, A-570-204)

1. ON 03/15/2005, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDERS ON HAMMERS/SLEDGES, PICKS/MATTOCKS AND AXES/ADZES FROM THE PEOPLE'S REPUBLIC OF CHINA (PRC) (A-570-201, A-570-203, A-570-204), EXPORTED BY TIANJIN MACHINERY IMPORT + EXPORT CORPORATION (TMC), AND THE ANTIDUMPING DUTY ORDER ON BARS/WEDGES FROM THE PRC (A-570-202), EXPORTED BY SHANDONG

HUARONG GENERAL GROUP CORPORATION (HUARONG), FOR THE PERIOD 02/01/2000 THROUGH 01/31/2001.

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 02-00637 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED ABOVE.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF HAMMERS/SLEDGES, PICKS/MATTOCKS AND AXES/ADZES WHICH WERE EXPORTED BY TMC, AND BARS/WEDGES WHICH WERE EXPORTED BY HUARONG, AND WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 2/01/2000 THROUGH 01/31/2001. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

4. LIQUIDATION INSTRUCTIONS FOR ENTRIES AFFECTED BY THIS INJUNCTION HAVE NOT YET BEEN ISSUED.

5. THESE INSTRUCTIONS TAKE EFFECT IMMEDIATELY.

6. THE DEPARTMENT OF COMMERCE WAS SERVED WITH THE ABOVE REFERENCED INJUNCTION ON 03/17/2005. PURSUANT TO THE TERMS OF THE INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS OF 03/18/2005.
