1. ON JANUARY 27, 1995, IN RESPONSE TO A REQUEST BY HERMANN-OAK LEATHER CO., SALZ LEATHER CO., PRIME TANNING CO., INC., IRVING TANNING CO., S.B. FOOT TANNING CO., WESTFIELD TANNING CO., SUNCOOK TANNING CORP., UNITED TANNERS, INC., AND PAUL FLAGG, INC., (PETITIONERS), THE DEPARTMENT OF COMMERCE ISSUED A PRELIMINARY SCOPE RULING THAT UPPER BOVINE LEATHER WITHOUT HAIR ON, NOT WHOLE, PREPARED AFTER TANNING AND NOT EXCEEDING 28 SQUARE FEET IS WITHIN THE SCOPE OF THE COUNTERVAILING DUTY ORDER ON LEATHER FROM ARGENTINA (C-357-803).

2. BECAUSE THE IMPORTED PRODUCT IS UPPER BOVINE LEATHER WITHOUT HAIR ON, NOT WHOLE, PREPARED AFTER TANNING AND NOT EXCEEDING 28 SQUARE FEET, AND SINCE THE PRODUCTS EXCLUDED BY THE DEPARTMENT FROM THE SCOPE OF THE ORIGINAL INVESTIGATION ARE WHOLE BOVINE, UPPER AND LINING LEATHER, NOT EXCEEDING 28 FEET, THE COMMERCE DEPARTMENT PRELIMINARILY FOUND THIS PRODUCT TO BE WITHIN THE SCOPE OF THE ORDER.
  
3. CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF LEATHER FROM ARGENTINA, INCLUDING UPPER BOVINE LEATHER WITHOUT HAIR ON, NOT WHOLE, PREPARED AFTER TANNING AND NOT EXCEEDING 28 SQUARE FEET, SUBJECT TO THE ANTIDUMPING DUTY ORDER COVERING LEATHER FROM ARGENTINA.
  
4. IF THERE ARE ANY QUESTIONS REGARDING THIS MATTER BY CUSTOMS OFFICERS, THEY SHOULD BE FORWARDED VIA E-MAIL, THROUGH THE APPROPRIATE SUPERVISOR CHANNELS, TO THE TECHNICAL PROGRAMS DIVISION, ANTIDUMPING/COUNTERVAILING DUTY BRANCH USING THE ATTRIBUTE "HQ OAB." THE IMPORTING PUBLIC AND INTERESTED PARTIES SHOULD CONTACT RON TRENTHAM ON 202-482-3931, OFFICE OF ANTIDUMPING COMPLIANCE, IMPORT ADMINISTRATION, INTERNATIONAL TRADE ADMINISTRATION, U.S. DEPARTMENT OF COMMERCE.
